

## ***“More Than A Paycheck” Site Use License***

Pastors, teachers and workplace leaders are now able to use the *More Than A Paycheck* course materials within the context of their own church, school or business, using the PowerPoint slides, speaking notes and video clips developed by Dr. Christian Overman, and used when he presents this course himself.

The complete *More Than A Paycheck* course contains 24 sessions, with over 650 PowerPoint slides, 50 video clips, and complete speaking notes. Material in this course contains the basic content of two books by Dr. Overman, namely, *God’s Pleasure At Work: Bridging the Sacred-Secular Divide*, and *The Difference One Life Can Make: Experiencing God’s Pleasure At Work*.

The materials themselves remain the property of Worldview Matters®, as explained in the attached Site Use License, but as long as the parameters of the Site Use License are observed, the authorized Site Presenter is allowed to keep and use the materials indefinitely. Below is the one-time license fee:

License Fee for Part 1 only (*God’s Pleasure At Work*) = \$275\* (*Includes 12 sessions, approx. 325 PPT slides, 25 video clips, speaking notes and 10 Participant Guides*)

License Fee for Part 2 only (*The Difference One Life Can Make*) = \$275\* (*Includes 12 sessions, approx. 325 PPT slides, 25 video clips, speaking notes and 10 Participant Guides*)

License Fee for Part 1 & 2 Combined (complete set) = \$495\* (*Includes 24 sessions, 650 PPT slides, 50 video clips, speaking notes and 20 Participant Guides*)

Additional Participant Guides are available to authorized Sites at a 25% discount (\$6 each.)

# **Site-Use License to Present “*More Than A Paycheck*” Within a Local Church, School or Business Setting**

## **An agreement between *Worldview Matters*®, [WM] and \_\_\_\_\_, the *Site Presenter(s)* [SP]**

1. The SP acknowledges that he/she will be presenting the materials for his/her own congregants, employees, students, clients or trainees within the context of his/her regular school, church, business or ministry responsibilities. The SP also acknowledges that he/she is *not* authorized to present the course for the general public, that is, for people other than his/her own congregants, employees, students, clients or trainees in the context of his/her regular school, church, business or ministry responsibilities.<sup>1</sup>
2. WM affirms that the SP is authorized to present the course (in whole or in part) as often as desired within the context of his/her regular teaching responsibilities, for as long as desired.
3. Portions of the materials may be used by the SP without presenting the course in full. If the SP adds any content of his or her own to the presentation, he or she agrees that such content shall in no way conflict with the WM “Statement of Faith” as shown on the WM website ([http://www.biblicalworldview.com/a\\_beliefs.html](http://www.biblicalworldview.com/a_beliefs.html)). Such content shall be biblically sound, and shall not conflict with any other content of the course as developed by Dr. Christian Overman.
4. If the course is presented in full, it is recommended that the Participant Guide for the course be used for this purpose. To encourage such usage, WM provides 20 complementary Participant Guides with a Site Use License for Part 1 & 2 combined, or 10 complementary Guides with a Site Use License for Part 1 or 2 only. WM also will make additional Guides available to SP’s at a 25% discount when used for course purposes. The SP covers shipping/handling costs.
5. Within 30 days of the signing of this agreement, the SP (or the Site in which he/she works) agrees to pay a one-time license fee of \$495 for the complete course materials, or \$275 for Part 1 or \$275 for Part 2 only. Upon request, this amount may be spread over two or three months, if using a credit card for payment. Call Worldview Matters® (877.624.0230) to make these arrangements.

<sup>1</sup> For example, a pastor may present the course (or portions of it) as a Sunday morning sermon series or an adult Sunday School class, but he/she may not present the course as an event for the general public. A business leader may teach the course for his/her employees, but may not teach the course as an event for the general public. A schoolteacher may teach the course as part of his/her history or Bible class, but he/she may not present the course to the general public. A person who is part of a “parachurch” organization that hosts regular sessions for discipleship or training purposes may use the course (or portions of it) as part of this endeavor, but may not present the course to the general public. Because Worldview Matters must maintain a high level of quality control with respect to presenters who teach the course for the general public, and to ensure that a person attending a “More Than A Paycheck” course open to the general public in Atlanta, Georgia, will receive the same experience as a person attending a “More Than A Paycheck” course for the general public in Anaheim, California, Worldview Matters® is not able to authorize the SP to present “More Than A Paycheck” seminars for the general public.
